JOHN HUNTER LAWSUIT

Material from files of J.R. Fitzpatrick relating to lawsuit filed in Sangamon County Circuit Court by Citizens Tribune Incorporated against John Hunter in 1950. Citizens Tribune sought a judgement of \$4,656.41 allegedly owed the corporation by Hunter for advertising and printed material furnished to Hunter during the Spring, 1947 City Council campaign. Suit was tried in October, 1950, and Hunter found innocent.

Materials include some legal documents relating to lawsuit, background, and evidence against Hunter, and other general material on Hunter during his years in office. Related files contain background material kept by Fitzpatrick on Hunter and his various campaigns for re-election. John Hunter died in office on January 14, 1972.
