<u>Minutes</u>: Minutes from September Board Meeting were presented for approval. A motion to approve the minutes unanimously carried.

<u>Financial Reports</u>: September Financial Reports were presented with no anomalies. It was stated that we still had 55% of our finances remaining. Director Griffith and Fiscal Officer LaSalvia are currently working on the FY24 Budget.

### **Director's Report**:

### **General Updates**

- The original computer order has been cancelled and reordered from a new vendor.
- General improvements are happening. There are, however, difficulties with the building's dated infrastructure keeping up with current technological

- needs. Director Griffith is currently working with Amanda Long in purchasing on financing much needed elevator repairs.
- Hot spot check out is flourishing and is having success in the underserved wards
- Youth Services is working diligently to meet the needs of our community:
  - Approximately 15,000 ecards have been supplied to District 186 & parochial school students and teacher
  - o Library card holders have virtual access to live homework help
  - Staff is in the process of making 'classroom library cards' for physical checkouts available to teachers
  - YS has purchased decodables and high/low books for children with learning differences
  - YS staff is partnering with Boys & Girls Club for pop-ups and outreach events

#### **Bookmobile**

- We have accepted a bid! The bid came in at \$481,000. \$350,000 will come out of the bequest and the balance will come from Capital Funds.
- The bookmobile will act as a mobile branch with the capability of carrying 3,500 items
- A CDL is not needed to drive the bookmobile

## Microfilm Digitization Project

 SVC is in the process of digitizing 107 rolls of archived local newspapers and 18 rolls of city minutes

## **Programming and Outreach**

- The November 5<sup>th</sup> Bridgerton Murder Mystery event is quickly approaching and the staff has had to increase the registration limit based on the overwhelming requests for attendance.
- Youth Services is hosting a Children's Mystery event to partner with the Adult Services mystery event
- Library staff is participating in 10 outreach events in addition to multiple local pop-ups
- True Crime & Brew Time, Black Women Authors Book Club, Banned Book Café, and Civil Civics have all been very well attended
- Lincoln Library will be taking part in December 17<sup>th</sup> Holiday Walk

<u>President's Report</u>: Mr. Jordan stated that he was very happy with the library's surge in outreach events. He also thanked everyone who had donated Halloween candy to the library.

<u>Friends Report</u>: A letter stating Lincoln Library's intent to separate from the Friends of Lincoln Library has been sent.

Lincoln Library Bookshare has agreed to step-up as a supporting / fundraising group for Lincoln Library. This group is currently working on a name change and writing bylaws so that they may better partner with our library.
